MINUTES

METROPOLITAN EMPLOYEE BENEFIT BOARD

January 7, 2025

The Metropolitan Employee Benefit Board met for their regularly scheduled meeting on Tuesday, January 7, 2025 in the Sonny West Conference Room, Howard Office Building, 700 President Ronald Reagan Way, Nashville, Tennessee, at approximately 9:30 a.m.

Benefit Board members: Chair: Edna J. Jones; Members: Kevin Crumbo, G. Thomas Curtis, Harold W.

Finch, II, Gilbert Gonzales, B.R. Hall, Sr., Shannon B. Hall, and Robert Weaver.

Vice Chair: Christy Pruitt-Haynes and Jonathan Puckett were unable to be present.

Others present: Christina Hickey, Metro Human Resources, Nicki Eke, Metro Legal Department

and Dr. Kenton Dodd, Civil Service Medical Examiner.

A. MINUTES: Chair Edna Jones called the meeting to order and said the first order of business was to

determine if there were any amendments, corrections, or questions of the minutes from the last regular meeting held on December 3, 2024. With no corrections, nothing further was noted and B.R. Hall moved for approval. Robert Weaver seconded, and the Board approved without

objection.

B. APPEAL ANNOUNCEMENT:

Christina Hickey announced the process and timeframe for appealing a decision made by this Board.

C. DISABILITY PENSIONS: (new requests, reexaminations, return to work and social security approvals/referrals)

The terms of the approval or extension of the items listed in the motions are specifically stated in these minutes.

Dr. Kenton Dodd, Civil Service Medical Examiner, (CSME), and Hannah Robinson, CSME Assistant, reviewed the disability pensions with the Board.

It was suggested to take item 9 separately and it was noted that item 12 was withdrawn.

Dr. Kenton Dodd reported to the Board that he recommends approval of the disability pension new requests, items 1 through 8, 10, and 11 for the length of time as recommended. Tom Curtis moved for approval of the recommendation to approve the disability pension new requests, items 1 through 8, 10 and 11 for the length of time as recommended. Harold Finch seconded.

There was some discussion regarding item 3 and the injury on duty, the physicians statement removing him from all work despite the sparce medical information to support the request and the additional medical information on items 4 and 7 not changing the recommendation.

There was also some discussion of the post-traumatic stress disorder, (PTSD) claims related to the state law.

A vote was taken on the motion to approve the disability pension new requests, items 1 through 8, 10 and 11 for the length of time as recommended and the Board approved without objection.

The employee was present for item 9.

Byron Grizzle, Sheriff's Office was also present.

The employee addressed the Board regarding the request.

Byron Grizzle stated they will support whatever the Board can do in this case. He stated that the injury has been lingering and there has been some question regarding causation which led to the discovery of the cancer and the treatment for the injury on duty ceased.

C. DISABILITY PENSIONS: (new requests, reexaminations, return to work and social security approvals/referrals)

There was some discussion of the current disabling condition not being the job-related component, the medical and injury on duty pensions being the same amount, one is taxable and the other is not, and a prior case similar to this one.

There was some discussion regarding approving this as a medical disability pension and then switching to injury on duty if the treatment is successful and is medically cured and he is still disabled because of the injury on duty.

Dr. Kenton Dodd reviewed the medical record and stated that medically he cannot differentiate the symptoms because it is in the exact area.

Kevin Crumbo moved for approval of item 9 as injury on duty for the length of time as recommended. B.R. Hall seconded and the Board approved with Shannon Hall opposed.

Dr. Kenton Dodd reported to the Board that he recommends approval for continuing the disability pension reexaminations, items 13 and 14 for the length of time as recommended. Harold Finch moved for approval of the recommendation to continue the disability pension reexaminations, items 13 and 14 for the length of time as recommended. Tom Curtis seconded, and the Board approved without objection.

Dr. Kenton Dodd reported to the Board that on item 15 he requests a deferral for two months. Robert Weaver moved for approval of the request to defer item 15 for two months. Tom Curtis seconded, and the Board approved without objection.

BENEFIT BOARD ITEMS

The Human Resources staff submitted the following for the Board's consideration and appropriate action:

1. Public Comment Period.

A maximum of 10 persons who write their names on the sign-up sheet provided at the meeting will be allowed to comment on matters that are germane to items on the Agenda. There were no public comments.

2. In line of duty death benefit for Charles R. Pytlewski.

Christina Hickey reported to the Board that Charles R. Pytlewski was an active employee classified as a Police Sergeant with the Metropolitan Nashville Police Department and died on April 22, 2024 of cardiac hypertrophy according to the death certificate. She stated that under the benefit system, Mr. Pytlewski's beneficiaries are entitled to the basic term life insurance benefit which has been processed and Metro Code Section 3.20.040 (A) gives the Board the authority to provide an additional \$100,000 in-line-of-duty death benefit to Mr. Pytlewski's estate. She stated this request is now being made on behalf of his beneficiary, Ashley Hayes. Ms. Hickey stated that in accordance with the March 2014 Benefit Board approved IOD Death Benefit policy, a copy of the death certificate and the 101 form on file for the deceased has been provided and the Board will need to determine whether this case qualifies for the benefit afforded under Metro Code Section 3.20.040.

Robert Weaver moved for approval of the in line of duty death benefit for Charles Pytlewski. B.R. Hall seconded, and the Board approved without objection.

3. Redetermination of disability pension amount based on excess earnings.

Christina Hickey reported to the Board that staff has identified disability pensioners who have exceeded their outside allowable earnings amount and, in accordance with the Code, are to have their disability pensions adjusted accordingly. Ms. Hickey stated that the affected members have been notified of the adjustments.

Lori Meyer and Janel Donaldson, Human Resources staff, were available for any questions.

B.R. Hall moved to accept the report and have the individual's disability pensions adjusted accordingly. Kevin Crumbo seconded, and the Board approved without objection.
