If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

#### VII. ADMINISTRATIVE MATTERS

#### **2025 PRIVILEGE TAX PAYMENTS**

Staff request Board approval to issue a \$500 civil penalty offer in lieu of a hearing to first time violators of M.C.L 7.08.060 Fees –Application, renewal and change in management.

B. All permit holders shall pay an annual privilege tax of one hundred dollars to the metropolitan beer permit board for the privilege of selling beer within the state, pursuant to Tennessee Code Annotated Section 57-5-104(b)(1).

Second offense violators will be issued a \$1000 civil penalty offer in lieu of a hearing.

We currently have approximately twenty-eight outstanding 2025 privilege tax payments. List provided on page 26 and 27.

Notes: Assistant Director Terrence Darby informed the Board that the listed locations attached to this agenda have not paid their 2025 Annual Privilege Tax fee of \$100. He also stated that final notices were sent via certified mail on February 12th, and permit holders have 10 days from the date of receipt to submit payment. If payment is not received within that timeframe, a citation will be issued.

Additionally, the Board was informed that multiple attempts had been made—via phone, mail, and email—to notify the permit holders of the outstanding fee.

After a brief discussion, the Board voted to proceed with issuing citations, including recommended civil penalty amounts, for any unpaid fees beyond the 10-day deadline.

Motion: Issue citations to any location that has not paid the \$100 Annual Privilege Tax fee within 10 days of receipt of the final privilege tax notice. The civil penalty will be \$500 for a first-time offender, in lieu of a hearing, and \$1,000 for a second-time offender, in lieu of a hearing.
