Ms. Lucy Kempf thanked the Board for their service to the city and their work on the Parks Board. Ms. Kempf acknowledged the work of the Director Odom and the Parks team for their collaboration on this project, along with NDOT, Planning staff, the Friends of Warner, Cheekwood and as well as many neighborhoods representative associations. Ms. Kempf stated that the Planning Commission is enabled by state law to manage growth through the effectuation of a general plan and that includes the placements of streets, parks, cultural uses, residential neighborhoods, that tend to

take a holistic look how we as a city should be growing and should be managing our relationships to one another from a land use perspective and so it's from that perspective that they provide recommendations around all of our studies. Ms. Joanie Williams, Assistant Director of Urban Design, Metro Planning Department shared recommendations from the Belle Meade Highlands Design and Mobility study implementation plan adopted by the Metro Planning Commission at their January 9<sup>th</sup> meeting. Ms. Williams reported that this is an informational presentation summarizing recommendations of the Metro Nashville Planning Commission for the Parks Board. No action is requested today, but the Planning Commission does recommend action around parking and access at a future date.

## MS. JENNY HANNON, PRESIDENT OF THE FRIENDS OF WARNER PARKS ADDRESSES BOARD REGARDING THE "BELLE MEADE HIGHLANDS STUDY".

Ms. Jenny Hannon, President of the Friends of Warner Parks, reported that for nearly 100 years Warner Parks has been a treasured resource for all of the community that was intended by Luke Lee when he gave the land in 1927 and is intended by his family today. As Warner Parks has grown and evolved so too has its usage and popularity, every decision made about the park both in the past and moving forward must prioritize what is not only best for Warner Parks but for the entire Nashville Park system ensuring they remain accessible, well-maintained, and enjoyable for the entire community.

Ms. Hannon introduced Mr. Terry Cook. Mr. Terry Cook reported that he has over 30 years of conservation experience on the ground managing and acquiring land and ensuing the sustainability of the properties. Mr. Cook commented that nearly 100 years ago the city was gifted over 800 acers that make up a large part of Percy Warner Park, the park has become a foundational piece of the community. It is rare for us to have an urban park of this size and significance. Mr. Cook cautions that large parks like Warner can be subject to a death of a thousand cuts and caution against allowing this to occur.

#### THE FRIENDS OF TWO RIVERS PRESENTS ANNUAL UPDATE TO THE BOARD.

Mr. Phil Claiborne, President of the Friends of Two Rivers provided an update highlighting the FY2024 financials, community events, and FOTR's master plan improvement achievements during his presentation. Mr. Claiborne announced that former Council Member Jeff Syracuse as the new vice president.
