Quarter 1 2025 Report (Jan - Mar)

- **Public Speaking**: Held Zoom practice event for 4-H'ers advancing on to the Area Public Speaking contest. Had 7 4-H members participate in the Area 1 Public Speaking Contest and served as co-chair. Awards won in Davidson County were 2nd and 3rd place in the 6th grade contest, and 5th place 4th grader.
