If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

#### Notes:

The Board had a lengthy discussion about whether the two locations should be cited for each gambling device or cited once, given that it was the same event where multiple machines were found. It was also discussed why there is a separate violation for M.C.L. 7.08.140R – criminal activity on the premises.

Inspector Brown informed the Board that the Vice Division of the Metro Nashville Police Department has been understaffed for at least the last two years, resulting in no enforcement of gambling violations until now. He emphasized the severity of these cases and believes that the locations should be cited for each gambling machine because they are making money from each machine and doing so illegally.

Chairperson Taylor expressed concern about citing the locations for multiple offenses when, in fact, all the offenses occurred during the same event.

Legal Counsel, Mr. Garth, advised that the Board should consider that, in these two cases, criminal activity under M.C.L. 7.08.140R is also being cited, which is not the case for other violations like selling beer to a minor. In those cases, criminal activity on the premises is not cited. He did not recommend removing these violations but suggested the Board remain consistent in how violations are cited.

Director McDonough shared his opinion, stating that the Board could argue it doesn't typically cite for criminal activity on the premises in other cases (such as selling beer to a minor), as it is often difficult

to prove that the location is knowingly selling to minors. However, in this case, the permit holder intentionally went through the process of bringing the machines onto their premises and allowing illegal gambling to take place.

After the discussion, the Board voted to approve the citations as written. If the permit holder disagrees with the civil penalty amount, they have the option to request a hearing. If a hearing is requested, the Board will hear the permit holder's testimony and may determine a different outcome.

Inspector Brown informed the Board that a minor was sent in and attempted to purchase beer. The clerk did ask for identification but still made the sale. He noted that this location didn't have much beer on the premises and that, in his belief, they don't sell much beer. Inspector Brown stated that everyone was very cooperative during the inspection.

Mr. Buggs informed the Board that he believes the clerk purposely made the sale of beer to the minor due to personal issues between the clerk and the owner. He also mentioned that he is in the process of pressing charges against the clerk for stealing over \$5,000 from him, which occurred approximately 10 days after this infraction.

Ms. Fox asked Mr. Buggs if he let the employee go after the sale to the minor.

Mr. Buggs replied that he did not initially let the employee go, as it was recommended by Inspector Brown to provide further training rather than termination. Mr. Buggs conducted additional in-house training for his staff. While this training was not official Beer Board training, it was provided by one of his bartenders who has been a bartender and manager for 15 years. Additionally, they placed a calendar by the register with a message that essentially read, "Do not sell before this date." However, Mr. Buggs did let the employee go after the theft occurred.

After upholding the citation, the Board briefly discussed whether the civil penalty amount should be reduced. After considering that the permit holder was cooperative and implemented measures to prevent a recurrence, the Board decided that the fine should be reduced, as has been done in similar situations in the past.

Inspector Brown also reported that two minors entered the location and successfully purchased beer and tobacco products from two separate clerks.

Mr. Meyer informed the Board that the two clerks who sold beer and tobacco to the minors bypassed the system by entering different birth dates. He stated that this bypass capability has now been removed from the location.

The Board held a brief discussion and decided that, due to the new implementations and in keeping with previous hearing outcomes, the civil penalty amount should be reduced from \$3,000 to \$2,500.
