<u>Code Provision:</u> 2018 IPC section 410.3. 1 High and low drinking fountains. Not fewer than two drinking fountains shall be provided. A single drinking fountain with two separate spouts that complies with the requirements for people who use a wheelchair and standing persons shall be permitted to be substituted for two separate drinking fountains. <u>Variance Requested:</u> In lieu of the drinking fountains, appellant is requesting the substitution of readily available water bottles in each dressing room and in the reception area. Alternative option is to purchase a water dispenser unit.
