## APPEAL OF DECISIONS

If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

2025 Privilege Tax Season.

### Notes:

Asst. Director Terrence Darby informed the Board that the 2025 privilege tax season has been closed out. He also advised that we would be re-visiting the Beer Board Vendor Training Program. The Board was informed that staff plans to have a draft available for board review and approval by the end of the current fiscal year. The training will be something similar to the Responsible Vendor Program that the state currently has in place.

Inspector Melvin Brown discussed the challenges of compliance testing underage beer sales due to a shortage of police officers, which has led to a focus on more serious crimes. If approved, the Beer Board may consider having Beer Board inspectors write Metro citations themselves, which could save time and resources. The board also debated the pros and cons of criminal versus Metro citations, noting that criminal citations have more severe consequences.
