# METROPOLITAN NASHVILLE-DAVIDSON COUNTY TRANSPORTATION LICENSING COMMISSION

#### **Minutes**

# April 17, 2025

The Metropolitan Nashville-Davidson County Transportation Licensing Commission (MTLC) met for its regular meeting on this date in the Jury Assembly Room of the Justice A.A. Birch Building. Present were Chair Pat McNally, Vice Chair Carol Westlake, Commissioners Carey Rogers, Annie Klaver, Michael Hayes, and Erica Penley (6). Also present were NDOT staff members Diana Alarcon, Lisa Steelman, Richard Rooker, Amanda Mullins, and T.D. Schlafer, as well as Metro Legal advisors Erica Haber and Phylinda Ramsey.

In the absence of the Chair, the Vice Chair called the meeting to order, then led the Pledge of Allegiance, followed by a reading of the Notice of Appeal Statement which outlined the right of appeal of MTLC decisions.

The Vice Chair opened the floor for public comment from those gathered. Jeanette Barker spoke. There were no further requests to speak.

Commissioner Hayes with a second from Commissioner Klaver moved approval of the minutes from the previous meeting.

The Vice Chair called the meeting back to order.

OPVH company Maxtor GG submitted a request to change their name to Maxtor GG LLC. Commissioner Klaver with a second from Commissioner Rogers moved to approve.

# **Entertainment Transportation (ET)**

The Vice Chair opened the Annual Hearing for the purpose of consideration of applications for Certificates of Public Convenience and Necessity. There were no requests to speak. The Vice Chair closed the Annual Hearing.

The Commission deliberated the number of ET vehicles required to meet the Public Convenience and Necessity as required by Metro Code 6.77.030 and MTLC Rules and Procedures Section 801 C.

# 6.77.030 - Findings—Issuance of certificate, renewal or additional permits.

A. The MTLC must make a prerequisite finding as to what number of entertainment transportation vehicle service providers and vehicles are required by the public convenience and necessity, in the metropolitan government area, before it may issue any new certificates of public convenience and necessity, renew any previously issued expiring certificates, or add any additional permitted vehicles to an existing certificate-holder's permitted fleet. Further, the MTLC must find that an applicant is fit, willing, and able to provide such service and to conform to the provisions of this chapter and the rules promulgated by the MTLC, before the MTLC may issue a certificate of public convenience and necessity to a particular applicant. The certificate shall state the name and address of the applicant, the number of vehicles authorized upon such certificate and the date of issuance.

B. In making the above findings, the MTLC shall, at a minimum, take into consideration the number of entertainment transportation vehicles already in operation, whether existing service is adequate to meet the public need, or so great as to be exceeding the public need and unnecessarily adding to traffic congestion; the character, experience, financial condition and responsibility of the applicant, and such criteria as may be adopted by the MTLC in its rules.

# MTLC Rules and Procedures Section 801 C

In making the finding for the award of a Certificate of Public Convenience and Necessity, the MTLC shall, at a minimum, take into consideration:

- 1) The number of ETV already in operation.
- 2) Adequacy of existing service to meet the public need.

- 3) The applicant's experience in the operation of an ETC and its vehicles.
- 4) The applicant's history of violations and/or citations of alcohol laws, noise violations, HUB Nashville complaints, and other non-compliant behavior.
- 5) The ability of the applicant to comply with the laws and regulations, including the equipment and service proposed to be furnished.
- 6) The applicant's financial responsibility and condition.
- 7) Safety of the public in the operational area.
- 8) The probable effect of increased service on local traffic conditions.
- 9) Traffic flow.
- 10) Compliance with existing noise ordinances.

Vice Chair Westlake reminded the Commission that at the ET Annual Meeting in May 2024, the optimal number of ET vehicles was unanimously set between 35-70. The Commission acknowledged that TCA 7-51-1008 prohibits a governmental entity from refusing to renew or revoking an ET permit except for good cause shown in an administrative hearing or after six months of dormancy.

Director Rooker shared that since the prior year's approval of 91 permits (41 ET, 50 SS), Nashville Bar Bus had surrendered one ET permit and Grooveline Party Bus did not apply to renew, resulting in 89 permits remaining (39 ET, 50 SS).

The Commission requested information on the recommendations of the Connect Downtown study. Mr. Schlafer quoted from the report, "The analysis showed that ETVs contribute to about 80 seconds of delay for each vehicle in the entertainment district. As the number of ETVs increases, the amount of delay increases as well. Connect Downtown recommends that the Transportation Licensing Commission consider reducing the number of ETV permits for Downtown Nashville. Given the impact of ETVs on traffic operations, our analysis shows that approximately 40 permits would have a less significant impact on traffic congestion."

Commissioner Penley with a second from Commissioner Klaver moved to set 40 as the optimal number of ETV permits based upon the Public Convenience and Necessity given the traffic congestion information provided by the Connect Downtown study, with the understanding that new information in the future could cause that number to change.

ACTION: Approved 3-0-1 (Commissioner Rogers abstained)
