A. MINUTES: Chair Edna Jones called the meeting to order and said the first order of business was to

#### **BENEFIT BOARD ITEMS**

The Human Resources staff submitted the following for the Board's consideration and appropriate action:

1. Public Comment Period.

A maximum of 10 persons who write their names on the sign-up sheet provided at the meeting will be allowed to comment on matters that are germane to items on the Agenda. Comments are limited to a maximum of two (2) minutes per person. To provide comment, you must sign up prior to the end of Item D on the Agenda.

There were no public comments.

2. Pension Committee report: (Chair: Jonathan Puckett; Vice-Chair: G. Thomas Curtis; Members: B.R. Hall, Sr., and Shannon B. Hall. (Alternates: Harold W. Finch, II and Christy Pruitt-Haynes)

Christina Hickey reported to the Board that the Pension Committee met on April 29, 2025 to deliberate on one appeal for a determination of pension plan status. She stated the Committee had a tie vote and therefore there is no recommendation to the full Board and the minutes from that meeting are being presented for approval by the Committee members.

Committee Chair Jonathan Puckett asked if there were any amendments, corrections or questions of the minutes from the April 29, 2025 Pension Committee meeting. With no corrections, B.R. Hall moved for approval of the Pension Committee minutes. Tom Curtis seconded, and the Committee minutes were approved without objection.

Dylan Lynch, Human Resources, was present.

The employee was present and addressed the Board. He noted that one person was allowed to move due to extenuating circumstances and gave a recap of his circumstances on this request and read a statement from his Councilman regarding the request to change pension plans.

Dylan Lynch stated the specific language that comes from the Code in this scenario is very specific and states that someone can not move from A to B after December 31, 1995.

There was some discussion regarding the Boards authority to construe any employees benefit including questions relating to the eligibility to become a member of any benefit plan.

Nicki Eke, Legal Department, stated that the Court of Appeals from the Faust case of 2006 stated that while the Board has the authority to construe the Metro pension plans, the Board is not empowered to construe an ordinance in a manner inconsistent with the provisions of the ordinance itself.

After some discussion regarding the Board not having the authority to construe the benefit ordinances in the Code in a manner that's contrary to the plain language of the ordinance adopted by the Council, Edna Jones moved to deny the appeal. Harold Finch seconded, and the Board approved with B.R. Hall and Jonathan Puckett opposed.
