The Metropolitan Employee Benefit Board's Medical & Life Committee met on Tuesday, May 27, 2025, in the Sonny West Conference Room, Howard Office Building, 700 President Ronald Reagan Way, Nashville, TN at approximately 9:38 a.m.

Christina Hickey called the meeting to order and stated that the first order of business will be to elect a Vice-Chair and stated she will also be helping the Vice-Chair conduct the meeting.

Christina Hickey opened the floor to nominations for Vice-Chair.

Edna Jones nominated Christy Pruitt-Haynes for Committee Vice-Chair. Shannon Hall seconded. A vote was taken on the nomination of Christy Pruitt-Haynes for Vice-Chair and the Committee approved without objection.

The Human Resources staff submitted the following for the Committee's consideration and appropriate action:

1. Public Comment Period

2. Self-insured Cigna HRA plan appeal – Dependent of employee from Metropolitan Nashville Police Department.

Christina Hickey reported to the Committee that an employee from MNPD and their dependent, participating in the Cigna self-insured HRA plan, are appealing fertility coverage (frozen embryo transfer cycle). She stated the employee and dependent are appealing the Cigna HRA plan non-coverage of fertility services and have supplied documentation on their appeal. She stated that Cigna has also supplied documentation on the denial and the plan provisions have also been provided.

The employee and dependent were present and addressed the Committee regarding their appeal.

Corey Riggs, Cigna, was present. He stated that fertility is not a covered benefit.

After some discussion of studying this benefit and that the plan provisions don't allow for it, Edna Jones moved to uphold the denial of the appeal. Shannon Hall seconded, and the Committee approved without objection.
