OTHERS PRESENT: Shannon B. Hall, Human Resources Director; Nicki Eke, Metro Legal Department Attorney

Chairman Farmer called the meeting to order. He asked if there were any corrections or additions to the minutes of the last Regular meeting on <u>May 13, 2025</u>. Commissioner Jones moved to accept the minutes for the <u>May 13, 2025</u>, meeting. Seconded by Commissioner Link, and Commissioners Link, Evans and Jones approved without objection. Chairman Farmer also asked if there were any corrections or additions to the minutes of the Public Hearing on <u>May 13, 2025</u>. Commissioner Link moved to accept the Public Hearing minutes. Seconded by Commissioner Jones, and Commissioners Link, Evans, and Jones approved without objection. Chairman Farmer asked if there were any union representatives in attendance. IAFF and SEIU representatives were present. Nicki Eke read the Announcement of Appeals Process. Chairman Farmer asked the Commissioners if they had received any Communiques from the public.

MOTION: After some discussion, Commissioner Evans moved to approve the revision to Civil Service Rule 5.7 – Special Pay Provisions, allowing short-term military leave (not to exceed 10 days per military service requirement) during a work period to be counted as time worked for the purposes of calculating overtime or compensatory time.
