NOFO Calendar

Last year, the U.S. Department of Housing and Urban Development (HUD) announced that they will be moving to a 2-year cycle for the Continuum of Care (CoC) Competition Notice of Funding Opportunity (NOFO). With ongoing changes at HUD, however, the CoC is preparing in case HUD decides to revert to the annual NOFO cycle. In the event that HUD releases the CoC NOFO, the following steps will be taken to facilitate the local competition. Specific dates will be announced based on timeframes outlined in the NOFO.

- CoC Application Interest Meetings
- CoC Application Submission Training for New Users
- Local Renewal Application opens
 - Renewal Application Addendum issued
 - Renewal applications due
- Local New and DV Bonus Applications open
 - New and DV Bonus Addendums
 - New and DV Bonus applications due
- CoC Performance Evaluation Committee rates and ranks Renewal projects
- CoC Performance Evaluation Committee rates and ranks New and DV Bonus projects
- Project applicants are notified of rating, ranking, and appeals process
 - Deadline for applicants to submit appeals
 - Meeting of the Appeal Panel
- Homelessness Planning Council finalizes the rating and ranking of applications
- All ranked projects submit applications via HUD's online e-snaps system
- Collaborative Applicant posts the Consolidated Application and Priority Listing online
- Collaborative Applicant submits the Consolidated Application to HUD via e-snaps
