



- BIKEWAY SIGNAGE SHALL BE PLACED PER DIRECTION OF THE FIELD ENGINEER.
- SHARROW AND BIKE LANE PAVEMENT MARKING SHALL BE PLACED PER DIRECTION OF METRO REPRESENTATIVE.
- SHARROW AND BIKE LANE PAVEMENT MARKING SHALL NOT BE PLACED IN FRONT OF DRIVEWAYS.
- BIKEWAY PROJECTS SHALL COORDINATE WITH METRO TRAFFIC DEPARTMENT.
- THE DESIGN IS BASED ON AERIAL IMAGERY FROM BING MAPS USING AUTODESK CIVIL 3D SOFTWARE; ALL SPACING AND DIMENSIONS MUST BE FIELD VERIFIED BY THE CONTRACTOR
- THE CONTRACTOR MUST NOTIFY THE ENGINEER AFTER PLACING TEMPORARY MARKINGS. THE ENGINEER WILL VERIFY DIMENSIONS BEFORE PERMANENT STRIPING IS APPLIED.
- ALL PAVEMENT MARKINGS SHALL BE THERMOPLASTIC UNLESS OTHERWISE SPECIFIED.

#### DETAIL NO. 3

#### NOTES:

- REFER TO MUTCD 2023 EDITION PART 9 FIGURE 9E-1 WORD, SYMBOL, AND ARROW PAVEMENT MARKINGS FOR BICYCLE LANES. REDUCED SIZE MARKINGS TO BE USED WHERE REQUIRED IN THE FIELD. REFER TO FIGURE 9E-9 FOR SHARED LANE MARKINGS.
- IF USED IN A SHARED LANE WITH ON-STREET PARALLEL PARKING, SHARED LANE MARKINGS SHOULD BE PLACED SO THAT THE CENTERS OF THE MARKINGS ARE AT LEAST 12 FEET FROM THE FACE OF THE CURB, OR FROM THE EDGE OF THE PAVEMENT WHERE THERE IS NO CURB. (2023 MUTCD, SECTION 9E.09)
- IF USED ON A STREET WITHOUT ON-STREET PARKING THAT HAS AN OUTSIDE TRAVEL LANE THAT IS LESS THAN 14 FEET WIDE, THE CENTERS OF THE SHARED LANE MARKINGS SHOULD BE AT LEAST 4 FEET FROM THE FACE OF THE CURB, OR FROM THE EDGE OF THE PAVEMENT WHERE THERE IS NO CURB. (2023 MUTCD, SECTION 9E.09)




#### SIGN INSTALLATION NOTES

- 1. ALL SIGNS SHALL BE INSTALLED IN THE APPROXIMATE LOCATIONS SHOWN ON PLAN SHEETS. ANY DEVIATION MUST BE APPROVED BY THE METROPOLITAN DEPARTMENT OF PUBLIC WORKS.
- 2. SIGNS SHALL BE INSTALLED IN STRICT ACCORDANCE WITH THE CURRENT EDITION OF THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (2023 MUTCD), AND SHALL HAVE THE HEIGHT AND CLEARANCE SPECIFICATIONS SHOWN ON THIS SHEET.
- 3. ALL SIGNING EQUIPMENT AND INSTALLATION PROCEDURES SHALL COMPLY WITH THE T.D.O.T. STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION, SECTION 713 - HIGHWAY SIGNING, AND WITH THE SPECIFICATIONS OF METROPOLITAN NASHVILLE AND DAVIDSON COUNTY.

#### HEIGHT AND LATERAL LOCATION OF SIGNS - TYPICAL INSTALLATIONS









- 1. CONTRACTOR SHALL VERIFY EXISTING ASPHALT THICKNESS IN THE FIELD.
- 2. CONTRACTOR SHALL SAWCUT THE EXISTING ASPHALT PAVEMENT TO THE PROPOSED RADIUS AS SPECIFIED IN THE PLANS.
- 3. DEPAVED ASPHALT AND OTHER EXCAVATED MATERIAL SHALL BE DISPOSED OF BY THE CONTRACTOR.
- 4. TOPSOIL (MAX. 6" DEPTH) SHALL BE PLACED IN DEPAVED AREA.
- MAINTAIN EXISTING GRADE/TOPOGRAPHY/DRAINAGE PATTERN WITH TOPSOIL INSTALLATION.
- IF EXISTING ASPHALT BEING REMOVED HAS A THICKNESS GREATER THAN 6", THEN ADDITIONAL MINERAL AGGREGATE, TYPE A BASE, GRADING D GRAVEL (ITEM NO. 303-01.08) SHALL BE PLACED UNTIL 6" TOPSOIL DEPTH CAN BE ACCOMPLISHED.
- SEEDING SHALL BE PLACED ON SURFACE OF TOPSOIL
- 8. THE CONTRACTOR SHALL BE RESPONSIBLE FOR COORDINATION OF ANY AND ALL UTILITY RELOCATION WORK.
- 9. EXACT UTILITY LOCATIONS SHALL BE DETERMINED IN THE FIELD CONTACTING THE UTILITY COMPANIES INVOLVED.
- 10. EXISTING STOP SIGNS ARE TO BE RELOCATED SO EDGE OF SIGN FACE IS 2 FEET FROM THE PROPOSED EDGE OF PAVEMENT. ENSURE STOP SIGN IS WITHIN 4 FEET OF STOP LINE AND THE STOP LINE SHALL NOT PRECEDE THE STOP SIGN. PLANS SHOW THE PROPOSED RELOCATED SIGN PLACEMENT.
