### **2. Metrics Review (OHS)**

- Review of key data points, including:
  - Total people experiencing homelessness in HMIS (% m/m)
  - Total housed last month (% m/m)
  - Housing placements from Rapid Re-Housing, Emergency Shelter, and Street Outreach (% m/m)
  - Available vouchers and budget utilization (% m/m)
  - Affordable housing units available in LBHC (% m/m)
  - Total OTC BNL and perm housing placements from OTC (% m/m)
  - Success awareness score at CoC (% m/m)
  - People in RW, MHNC, and OTHER (% m/m)
  - Negative exits (% m/m)
  - Individuals in perm housing for more than 90 days from OTC (% m/m)

### **3. Current Goals Review**

- **Identify shelter capacity challenges:** A workgroup is off track and will resume in September. The top issue is medical referrals overburdening shelters, and solutions are being developed.
  - *Success Milestones:* Identify four medical respite options, get 50 referrals to new options, and decrease NRM medical referrals by 20% by Dec 1, 2025.
- **Increase outreach capacity:** A workgroup is off track and will resume in September. The top issue is outreach programs lacking options beyond CE input and emergency relief, which limits housing effectiveness.
  - *Success Milestones:* Identify 10 outreach organizations, record effective housing navigation trainings, track participation, and increase housed individuals from Street Outreach by 20% by Dec 1, 2025.

- **Improve communication with HPC/Comms/CoC:** This goal is off track, with a due date of September 2025. The top issue is a lack of cohesion and awareness within the CoC.
  - *Success Milestones:* Publish a monthly dashboard and newsletter, measure the CoC's awareness of community progress, and celebrate a 15% increase in housed individuals system-wide by Dec 1, 2025.
- **Monitor voucher utilization:** This goal is off track, with a due date of December 2025. The top issue is historically poor voucher utilization, limiting the number of vouchers offered to Nashville.
  - *Success Milestones:* Maintain 95% or greater utilization for both voucher-based programs and budget-based subsidies, and increase capacity of vouchers and subsidies by 15% by Dec 2025.
