- 1. CALL TO ORDER
 - Chair Ben Tran
- 2. CONFIRM QUOROM
 - Quorum was confirmed at 4:15pm.
- 3. PUBLIC COMMENTS
 - There were no public comments.
- 4. REVIEW AND APPROVAL OF MINUTES
 - The minutes were approved with no edits.
- 5. FINANCIAL UPDATE
 - ED Tucker presented the financial report stating that FY25 has closed.
- 6. OLD BUSINESS
 - No Hate on My Plate
 - ED Tucker provided an update about the most recent events.
 - The facilitator training was well attended and successful. ED Tucker explained that another training and community engagement kit to assist hosts with planning are currently in development. He further explained that although

there have been a few challenges in staffing and hiring, continued momentum has been maintained.

- Ice Cream Social Justice
 - ED Tucker provided comments about the most recent collaboration of the event with Metro Arts at the 37208 Building.

7. NEW BUSINESS

- Metro Planning Department presentation
 - Katie Kinesis from Planning Department presented the Housing and Infrastructure Recommendations Memo
 - 1. Phase One (Completed):
 - a. Assessment of zoning and infrastructure's effect on housing equity.
 - b. Extensive input and work sessions with Metro Planning and community members.
 - 2. Phase Two (Ongoing):
 - a. Drafting zoning code recommendations for middle housing expansion.
 - 3. Phase Three (Fall 2025):
 - a. Infrastructure mapping and potential zoning map changes.
 - 4. Phase Four (Through 2028+):
 - a. Evaluation of the new zoning tools' effectiveness.
 - 5. Commissioners engaged in discussion about the presentation with the speaker.
 - a. Commissioner Teague asked questions about how those selected for community engagement were identified and contacted and if they represented all parts racial and socio-economic areas of the city. Ms. Kinesis explained the intentionality and geographic sensitivity in choosing the 6 communities where the conversations took place. She further explained that council members assisted with disseminating the information about the work sessions to the communities. Language accessibility was also considered through translated recordings.
 - b. Commissioner Pastorek asked if the height in R and RS zoning would be reduced. She asked commissioners to note that reducing the height removes density from residential neighborhoods and forces it into roads, pikes and other commercial areas.
 - Commissioner Johnson expressed concerns about potential hinderances with creating a cohesive strategy with local and state agencies.
 - Travis Miller from Planning presented an overview of the Unified Housing Strategy (UHS)
 - 1. The Executive summary provided an overview of the UHS.
 - 2. Unified Housing Strategy (UHS)
 - a. Key findings from the community engagement and data analyses
 - b. Updated housing demands
 - c. Performance metrics
 - 3. 10-year implementation plan
 - a. Identifies key partners and responsible entities
 - b. Prioritize actions based on urgency

- c. Serves as a roadmap for public and private partners to advance housing solutions.
- d. Annual policy priorities
- 4. The plan emphasized a focus on housing for those earning ≤80% of the area median income.
- 5. Commissioners emphasized the importance of balancing growth with maintaining affordability and preventing displacement.
 - a. Chair Tran and Commissioner Pastorek expressed concerns about the individuals and families that the strategy does not address, the number of units needed for immediate housing. They posed questions about regulations for short-term rentals as well.
 - b. Commissioner Martin expressed disdain with excessive studies and reporting and suggested using previous and existing studies as a reference for preexisting problems. She also suggested that Metro use land that it already has to create housing. She also questioned how Nashvillians are benefiting from the most recent tax increase.
 - c. Commissioner Coleman mentioned concerns with state limitations that may exist in Nashville and not in other cities.
 - d. Commissioner Burton expressed concern about incentives that developers may receive for building in Nashville.
- 6. ED Tucker explained that the MHRC should develop a plan to work with the Planning department.
