#### **Comprehensive Proposal Questionnaire**

<u>Strengths:</u> Firm's response addressed everything requested in the RFP except for the weaknesses noted below. Firm will provide 40 hours of free loss control services.

<u>Weaknesses:</u> Q#13 - Initial reserve is set at 15 days vs 10 days for incumbent. Q#15 - Firm did not provide details on how savings were achieved. Q#22 - Firm's response was not clear.

### **TPA System Software Demo**

<u>Strengths:</u> Firm's response addressed everything requested in the RFP. Firm's interface is very user friendly. Firm provided a thorough articulate review of their system.

Weaknesses: No weaknesses were noted.

**Strengths:** Firm's response addressed everything requested in the RFP.

Weaknesses: No weaknesses were noted.

## **Comprehensive Proposal Questionnaire**

Strengths: Firm's response addressed everything requested in the RFP except for the weaknesses noted below.

Weaknesses: Q#7 - Firm's insurance levels not as high as other offeror. Q#8 - Firm did not provide details for revenue share with bill review and pharmacy subcontractors. Q#12 - Firm has had a terminated agreement. Q#17 - Firm did not address possible changes/plans for their computer system. Q#25 - Firm did not have a way to measure response time. Q#32 - Firm does not have many tier levels. Nurse case management is assigned to every lost time file. Q#39 - Firm states "For Metro adjusters and supervisors, Davies ensures participation in local workers' compensation seminars offered in the Nashville area, including those hosted by Vanderbilt University Medical Center, Concentra, and the Mid-South W/orkers' Compensation Association." When asked to clarify seminars/training attended by adjusters, firm's response was "Metro adjusters have not yet participated in any onsite injury-specific seminars. Q#40 - Firm did not answer the question, stated that "customizable services" were offered through "pricing options"

### **TPA System Software Demo**

Strengths: Firm's response addressed everything requested in the RFP except for the weaknesses noted below.

<u>Weaknesses:</u> Presentation was not succinct, and presenter often appeared unsure. The software that the firm demonstrated was not live. Q#1 - Some functions were not working for the demo. Imaged documents in paperless environment not available for viewing. Unclear if prior years OSHA converted to a new system. No Davies Connect portal "go live" date provided. Q#1 - Firm's dashboard is confusing/not user friendly. Q#1. Some functions were not working for the demo, representatives from the firm stated they had a meeting the morning of the demo to discuss the software's (Davie's Connect) "live" date. The firm stated that the software would be live "next week," but could not provide an exact date. Q#8 - No reports were demonstrated.
