1. CALL TO ORDER

Chairman Brandon Mason called the meeting of July 14, 2025, to order at 2:32 p.m. Chairman Brandon Mason announced the appeals process, Metropolitan Code of Laws 2.68.030.

"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

- Kary Martin- Resident 12th South, came to speak about parking issues. He feels that parking on both sides of Lawrence Street is creating a safety issue. He would like to see no parking on the south side of Larence from 11th to 12th.
- Misty Keenen- Property Manager at Ashwood. Spoke about the need for a loading zone at this location. She is also in support of having parking restricted on the south side of Larence from 11th St to 12th St.

- 5.1 CD 18: Authorization for new multiway stop control for Bernard Ave and 24th Ave S, requested by NDOT.
 - Andrew Smith with NDOT provided background to the request. Commissioner Haller supports the request and would like
 additional improvements to that intersection. Darren Pack with NDOT provided some additional insight surrounding
 improvements that are scheduled to be installed in the area. Commissioner Evans-Segall spoke to the need for the requested
 stop sign and the community support. Commissioner Haller moved to approve. Commissioner Gibbs seconded the motion.
 The motion was approved with no objections.
- 5.4 CD 18: Authorization to lower the speed limit on Blair Blvd between 21st Ave S and Belmont Blvd from 30 mph to 25 mph, requested by NDOT.
 - Commissioner Haller made a motion to approve. Commissioner Gonzales has seconded the motion. The motion was approved with Council Member Evans-Segal abstaining from this vote.
- 5.5 CD 19: Approval for future valet operation for proposed development on the north side of 409 Peabody St, requested by KCI, on behalf of the developer.
 - KCI has requested this item be deferred for one month. Commissioner Gibbs moved to defer one month. Commissioner Gonzales seconded the deferral. The motion was deferred for one month with no objections.
- 5.7 CD 19: Authorization for a new valet zone for up to three parking spaces on the north side of Molloy St on the NW corner of Molloy St and 1St Ave S, effective 11am 2 pm and 6pm -Midnight /7days, requested by Zuzu.
 - Emanuel Matyas with NDOT spoke to the valet request. Commissioner Haller questioned the hours since the restaurant
 doesn't currently serve lunch. David Shaffer with PMC confirmed the hours and Brunch only on the weekend.
 Commissioner Haller moved to approve the valet zone 6pm-midnight 7 days a week and 11am-2pm on Saturday and Sunday.
 Commissioner Gibbs seconded the motion. The motion was approved with no objections.
- 5.9 CD 19: Authorization of a new valet zone for up to three parking spaces on the east side of Louise Ave on the SE corner of Louise Ave and Elliston PI, effective 24/7, requested by Holiday Inn Express West End.
 - Emanuel Maytas with NDOT spoke to the need for the request. Commissioner Haller would like to know why they are asking for 3 spaces. She would like this to be reduced to two spaces. Commissioner Kornutick asked about the fee for the valet space. Brandon Boatswain with NDOT Laz Parking provided some additional insight into the request regarding the rational behind the three spaces and the need to move these away from the intersection. Commissioner Kornutick and Commissioner Haller are supportive. Capt. Williams moved to approve. Commissioner Haller seconded the motion. The motion was approved with no objections.

7. UNFINISHED BUSINESS

- 7.1 CD 19: Authorization to remove existing Loading Zone on south side of Church St west of McMillan St and replace with new No Parking or Standing Anytime from 15th Ave N to 16th Ave N, requested by NDOT.
 - Andrew Smith with NDOT would like a one-month deferral on this item. Commissioner Gibbs moved to defer one month. Commissioner Haller seconded the deferral. The motion was deferred one month with no objections.
- 7.2 CD 17: Consideration of a new Loading Zone on the east side of 12th Ave S at 1212 12th Ave S, not to exceed 80ft in length, effective 6am 9am/7days, requested by 2214 12 South Property LLC.
 - Andrew Smith with NDOT provided an update to the questions that were previously requested. Commissioner Kornutick is supportive of staff recommendations. Capt. Williams moved to approve staff recommendation of disapproval. Commissioner

Commissioner Gibbs would like to direct folks to use HUB Nashville and asked if we would direct folks to do this.

Chair Mason would like a presentation on how we respond to outages. How they are monitored and how we get alerts out. Chair Mason would like to know how we ensure signals, marking and signage are refreshed and maintained.

Traffic and Parking Commission Authority:

Chapter 9 of the Metropolitan Charter, Sec. 11.904. - Function of commission as to traffic regulation.

For the purpose of making the roads, streets and other public ways safe for pedestrians, motorists and others, and for the purpose of facilitating the flow of traffic thereon, the commission is hereby authorized to adopt and publish traffic regulations, including the erection of proper signs necessarily and properly connected with or incident to the following:

(a)The location and time when parking shall be limited.(b)Places where parking shall be prohibited entirely or only during certain hours.(c)The establishment of stop sign controls for through streets or isolated intersections.(d)The establishment of traffic signal controls.(e)The direction in which traffic may use any street or portion of a street.(f)Restrictions on the size of vehicles using certain streets.(g)The establishment of speed zones upon metropolitan streets and roads based upon the findings of the commission. When such zones are properly signposted, the speed indicated on the signs shall be the legal speed limit.

Such traffic regulations adopted by the commission shall take effect five (5) days after they have been published in a daily newspaper of general circulation within the area of the metropolitan government and after a certified copy thereof has been filed with the metropolitan clerk and the chief of police. Such regulations, when so adopted, shall have the force and effect of an ordinance, and shall be enforced by the metropolitan police. The metropolitan council shall provide by ordinance for the punishment of violators of such traffic regulations and shall fix proper and adequate fines and penalties.
