Where a common multistory duct system is designed and installed to convey exhaust from multiple clothes dryers, the construction of the system shall be in accordance with all of the following: 4. The ductwork within the shaft shall be designed and installed without offsets. '18 IMC 505.5 Common exhaust systems for domestic kitchens located in multistory structures. Where a common multistory duct system is designed and installed to convey exhaust from multiple domestic kitchen exhaust systems, the construction of the system shall be in accordance with all of the following: 4. - 2. Provide a bathtub/shower.
- 3. Provide high and low drinking fountains.
- 4. Provide a service sink.
