#### MR TIM NETSCH PRESENTS PLAN TO PLAY UPDATE REPORT TO THE BOARD

Mr. Tim Netsch provided an update on the Plan to Play Parks and Greenways Master Plan. The original countywide plan was completed in 2017, and the 2025 update will build on that plan to better prioritize park needs. Over 2,500 participants responded to the recent survey, and the data is currently being analyzed. Draft recommendations will be developed and presented for a second round of public engagement, with the process anticipated to conclude by March 2026.

## BOARD APPROVES TENNESSEE GOLF FOUNDATION TO FUNDRAISE FOR IMPROVEMENTS AND ULTIMATE RENOVATION OF THE TED RHODES GOLF COURSE AND CLUBHOUSE

Mr. Whit Turnbow, President of the Tennessee Golf Foundation, presented proposed conceptual improvements to the Ted Rhodes Golf Course and Clubhouse and requested approval to fundraise for the project. He also shared the history and legacy of Mr. Ted Rhodes. Upon a motion by Mr. DeLay, seconded by Ms. Scott-Barnes, the Board approved the request for the Tennessee Golf Foundation to fundraise for the improvements and ultimate renovation. The Foundation, a longstanding partner of Metro Parks and Recreation, will coordinate with Parks representatives on the project. The fundraising request does not involve funding from Metro Parks.

Ms. Cindy Harrison, Assistant Director of Greenways & Open Space, thanked her team for their recent work and reported that 0.65 miles of greenways have opened this year. She presented a slideshow highlighting each new segment. Currently, 1.34 miles of greenway segments are under construction, and 7 segments totaling 5.79 miles are in design or final permitting. Additionally, 81.89 acres of open space are in the process of being acquired.

#### **Charlotte Corridor Rail with Greenway**

- Developing easement agreement with Cheatham County Rail Authority for use of a portion of their land.

#### 440 Greenway Sevier Park to Brown's Creek Park

### 440 Greenway Park Plaza to Existing Interior Trails Centennial Park and 440 Greenway Phase One Lighting

- 0.2 Mile greenway extension
- This project will go to Purchasing for bidding this summer.
- Project scope includes extension of the greenway from the Park Plaza trailhead down to the intersection of 31<sup>st</sup> Avenue where it will tie into NDOT's 31st Avenue bike lanes and sidewalk project and the cycle track and sidewalks on the 28th Avenue Connector and to Centennial Park
- New 'gateway' entrance walls, landscaping and lighting for both this new segment and lighting for the existing 440 Greenway.

#### Whites Creek Greenway at Hartman Park

- 1-mile extension of the Whites Creek Greenway Mullins Park to Hartman Park. New trail will extend from Hartman Park along Tucker Road and across flood buyout property along West Hamilton Avenue to Buena Vista Pike.
- Project is in 60%/ Design Development phase.
- The project anticipates a connection with an NDOT bikeway project in the future that will facilitate the extension of the greenway further north onto property purchased by Metro Parks for this purpose.
- Design and permitting expected to be complete and ready for bid in late 2025/early 2026 (pending funding).

#### **PRIVATELY FUNDED GREENWAY PROJECTS**

#### Richland Creek Greenway - Belle Meade Plaza

- 2 Greenway Conservation Easement Agreements are being dedicated for this project from the developer and from the adjacent Ingram property.
- Staff has given approval of the Final SP design for the greenway and will continue to work through approval of final construction documents. The developer will construct the greenway from Hwy 70S, through the new development along Richland Creek, under White Bridge Road, across the back of the Ingram property and will connect with the existing trailhead at the Old White Bridge.
- This project includes extensive landscaping and riparian zone restoration, the greenway trail and trailheads, site furniture and lighting.
- This is a 3-year development buildout and once accepted by Parks staff, the greenway will be maintained in perpetuity by the development.

#### Harpeth River Greenway Ariza Bellevue

- Project includes construction of new greenway connection from existing trail on Morton Mill Road to existing pedestrian bridge and future park development on land donated by Dorothy Kate and Thomas Frist Foundation.
- The review and approval process for the Final SP is in progress.
- The project includes a 25-acre land dedication to Metro Parks, greenway design and construction, a greenway conservation easement and greenway connection across the developer's property to the adjacent Metro-owned Park property, waterline extension to adjacent park property, a greenway bridge under the CSX Railroad Bridge, as well as a vehicular bridge which will provide access to that adjacent park land.
- The greenway will be constructed before the start of building construction.
- Metro application was made to TDOT Excess Land Committee in March 2025, for acquisition of stateowned property currently leased to Metro

#### Cumberland River Greenway at 2nd and VanBuren

- This project involves a proposed greenway amendment and routing realignment of the existing greenway segment on this property which has been approved by the Greenways and Open Space Commission, the Park Board and Metro Council.
- The project will involve reconstruction of the existing greenway, new landscaping and lighting, and maintenance, all to be provided by the developer or future owners, in perpetuity.

### Harpeth River Greenway at Newsom Station residential development

 Project includes greenway easement dedication, design and construction of new segment of greenway, and associated landscape installation and maintenance. Continuing to work with the developer to establish routing for the greenway trail.
