Jenna Smith, Metro HR rep, appeared before the Commission to discuss the requested job descriptions revisions. She was joined by Jessica Stewart, SEIU. The revisions to the driver's license requirements ensure compliance with US employment laws including the American with Disabilities Act (ADA) by confirming that a driver's license can only be required when it is an essential function of the position. Removing the "no substitution" requirement of the job descriptions presented for revision broadens the applicant pool by allowing individuals with relevant experience, skills and knowledge, but without a degree, the opportunity to compete for the positions.
