A. Call to Order, Welcome, and Land Acknowledgement

Chair West called the meeting to order at 12:06 and confirmed quorum.

B. Public Comment

The following members of public provided public comments:

- 1. Princella Smith: Ms. Smith spoke about her Thrive grant application.
- 2. Nane Smith: Ms. Smith spoke about Princella Smith's Thrive grant application.
- 3. Isabel Tipton-Krispin spoke about Nashville Shakespeare Festival's Operating grant application.

C. Featured Artist: Devin Kern

Featured artists Devin Kern gave a presentation titled "Allowing Art: The Connection between Criticism and Collaboration." He spoke about his experience as an FY26 Thrive grant panelist and his role with Creative Mornings, highlighting monthly gatherings for Nashville creatives.

D. Approval of Minutes: August 28, 2025

A motion was made to approve minutes from August 28, 2025, by Commissioner Kalil and seconded by Commissioner Jester.

E. Action Items/Discussion

1. Public Art Committee - Nashville Youth Campus for Empowerment

Atilio Murga provided an update about the Nashville Youth Campus for Empowerment (NYCE) public art selection. He provided a brief reminder about the project details, and stated that the selection panel has concluded its work and selected an artist. The recommended finalist, William Denton Massey, was selected by the panel for his strong community engagement commitment and experience, trauma-informed process and design approaches, and artistic approaches and methods of using repurposed materials to create artworks. Discussion emphasized Massey's qualifications and ability to work within the project's accelerated timeline.

A motion was made by Commissioner Tre Hardin and seconded by Commissioner Heather Lefkowitz to approve William Denton Massey as the final artist for the Nashville Youth Campus for Empowerment public art project. The motion passed.

Staff will begin next steps to communicate the selection results to all finalists and next steps with Mr. Massey.

2. Nominating Committee

Commissioner Jester provided an update from the Nominating Committee, which recommended the following slate of officers for the 2025-2026 years: Chair Campbell West, Vice Chair Tré Hardin, and Secretary Heather Lefkowitz. Officer terms begin on November 1, 2025. After officers are confirmed, the Chair is responsible for making committee appointments. Committee rosters are effective beginning January 1, 2026.

A motion was made by Commissioner Tim Jester and seconded by Commissioner Wade to approve Chair Campbell West, Vice Chair Tré Hardin, and Secretary Heather Lefkowitz to serve as the Arts Commission officers for the 2025-2026 year. The motion passed.

3. Grants & Funding Committee

Commissioner Heather Lefkowitz provided an overview of the action items being brought to the Commission, including allocation decision, approval of Thrive grants, and approval of General Operating grants. She noted that the grants committee is bringing recommendations, and that the Commission may have conversation about all the decisions and outcomes being considered. She noted important considerations for discussion including the large number of applications received this cycle, the implementation of standing policy, and the Commission's goal and commitment to authorize grants and award funds by the end of the calendar year.

Macy Amos provided an overview of conflict-of-interest procedures, noting Commissioner's duty of independence and instances where Commissioners should recuse themselves from voting. Ashley Bachelder stated that she has copies of all Commissioners submitted conflict of interest forms and will facilitate the grant approvals so that Commissioners may recuse and abstain from voting as appropriate.

Ashley Bachelder provided an overview of a memo she prepared and sent to Commissioners in early September, noting an overview of grant policies and procedures, ongoing policy goals, and limitations and priorities for continual policy and procedural work to be done. She explained that the first action item is to approve the allocation between General Operating and Thrive grants. The Grants Committee recommended allocating 60% of the budget to Operating and 40% to Thrive. This recommendation maintains the Commission's commitment to growing the Thrive program and balances administrative capacity and operational support.

A motion was made by Commissioner Jilah Khalil and seconded by Commissioner Tim Jester to allocate 60% of the FY26 grant budget to General Operating Support grants and 40% to Thrive grants. The motion passed.

Ashley Bachelder provided a brief report to lead into recommendations for Thrive grant funding. She stated that there were 275 total Thrive applications. 57 were denied in technical review, and 218 were reviewed by the panel. The top 86 applications are recommended for funding, which amount to \$1,305,273. Discussion included noting the growth from 75 Thrive grants in FY25 to 85 in FY26, that all applicants who do not receive funding may request and be given their panelist scores, refinements to the rubric that was implemented for FY26, various eligibility requirements, and the need to require panelists to provide mandatory comments. Ashley explained that award notifications will be sent the day following the meeting.

Ashley explained that applications will be approved one-by-one that need separate votes due to conflicts of interest, followed by group approval for the remaining. Ashley read through the applicants and fiscal sponsors, where applicable, and called for abstentions where needed.

Ashley stated that Operating grant approvals are next. She provided a staff report, stating that 106 applications were received, 13 denied in technical review and 93 were reviewed by the panels. 79 applicants who received a score of 70% or higher are eligible for funding. She showed the distribution of grant amounts among the recommended grantees as categorized by size, noting the range of grants for each size category as follows: grants to micro-organizations \$1,837 - \$9,892, grants to small organizations \$6,786 - \$21,341, grants to medium organizations \$10,886 - \$44,399, grants to midsize organizations \$31,869 - \$40,206, and grants to large organizations \$27,784 - \$46,306. She noted that there is greater parity in grant sizes between the largest grants and smaller ones.

Commission discussed the recommendations and several aspects of the process, including comparison of scores across years, the processes from previous through current years of using outside adjudicators and community panelists, implementation of the rubric for the last two or three evaluation cycles. Ashley provided an overview of the panelist process, including the open call for panelists, training and orientation with the rubric, and the process for the in-person panel days, the number of panelists, and the amount of time for panel reviews. Commissioners who observed the panels shared an observation that the panel process appeared to run smoothly with robust engagement and discussion by panelists. Concerns were raised about variation in the outcomes of scores this year, which across the board were lower scores than the previous time the rubric was used. Commissioners discussed options of approving the recommendations today, taking actions to change the recommendation, or sending the recommendations back to the grants committee

A motion by Commissioner Knight to send the Operating recommendations for funding back to the Grants Committee to compare the difference in last year's scores to this year's scores. Commissioner Jester seconded the motion.

Additional discussion included how long-term and historical partnerships are captured or considered. Additional questions regarding what anticipated actions may be taken in grants committee. Concerns were raised about considering changes to Operating recommendations but not those for Thrive, and what the impact on the timeline would be.

Commissioner Knight restated the motion: A motion to send the for Operating grants back to committee to consider the significant difference in scores from last year to this year using the same rubric.

Organizations will be taken up for individual votes where abstentions are needed for conflicts of interest, followed by a group approval for the remaining.

Ashley read through the recommendations for large organizations that required abstentions.

Motion passed.

Having approved all recommended grants, Ashley summarized the overall distribution of \$3,263,200 breaks down as follows: 40% to Thrive, 1.5% to micro, 5.7% to small, 18.6% to medium, 24.9% to midsize, and 9.3% to large.

F. Chair's Report

Chair Campbell West shared that the Executive Committee will meet in the coming weeks and will share updates after that meeting. She thanks all applicants who applied for grants, and the Metro Arts staff and Grants Committee for running the FY26 grant cycle on in a demanding and navigating multiple cycles concurrently.

G. Executive Director's Report

Ashley Bachelder shared that Camille Greer has been confirmed and is officially the 11th member of the Arts Commission. She will start at the October meeting. Staff updates include the departure of long-serving Finance and Operations Coordinator Skyler Peterson, which Ashley stated was a planned departure and she thanked Ms. Peterson for all her years of service to Metro. Interviews will begin soon for a new Finance Officer position, and the Strategic Grants and Initiatives Manager and Public Art Manager recruitments will close in the coming days and weeks. Ashley shared that she is close to finalizing the process for bringing on a facilitator to work with the staff and Commission on a 60–90-day organizational alignment and planning process to complete in preparation for a director search.
