We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

(73) We are actively pursuing a language assistance partnership. The partnership will enhance accessibility by offering Language Assistance Services. This initiative ensures that all members of the public, regardless of their language proficiency, can engage effectively with the Beer Board. By breaking down language barriers, the collaboration fosters inclusivity and promotes better communication within the community.

As the 2026 privilege tax season draws to a close, less than 40 payments remain outstanding. Certified final notices will be mailed on Tuesday, 2/17/26. Those that have not submitted payment ten days after our receiving the signed receipt of certified notice will be placed on the next available meeting agenda for staff recommended citation approval.

The team has begun discussions on creating food truck permitting requirements and operations. This includes researching local regulations, any additional licenses or Metro approvals that may be required and drafting operational plans. Collaboration with local food truck vendors and city officials will ensure compliance and streamline the process. Our goal is to launch a successful and compliant food truck experience that delights our community.
