RECENT REGULAR INSPECTION: No violation

STAFF REMARKS: Nashville Skyline Hotel, LP has successfully completed the Beer Board Suggested Best Practices Training. Mr. Hardrick, the Beer Board Training and Safety Coordinator, conducted a site visit to verify and discuss the implemented safety measures to prevent the sale or service of beer to minors. The business has also passed two regular inspection visits, demonstrating a strong commitment to compliance and safety.

STAFF RECOMMENDATION: \$2000 Civil Penalty or 14 Day Suspension and 90 Day Probation.

Mr. Ayala was present representing Nashville Skyline Hotel, LP, and pleaded guilty to the documented violation. In the absence of Inspector Brown, Assistant Director Darby, presented the complaint to the Board on his behalf. After hearing brief testimony provided by Mr. Ayala and Assistant Director Darby, the Board voted unanimously to issue a \$1750 civil penalty offer or 10-day suspension followed by a 90-day probation period. The Board stated the reduction in civil penalty was due to efforts and initiative put forth by Nashville Skyline Hotel, LP by successfully completing Beer Board Suggested Best Practices Training, passing two beer buy compliance checks, and receiving an onsite visit by Mr. Hardrick, Beer Board Training and Safety Coordinator, who verified that Nashville Skyline Hotel, LP has implemented the precautionary measures discussed during training to avoid future beer sales to minors.
