Staff advised that the complaints will be updated to ensure consistency with recently issued citations involving similar violations.

(61) Executive Director McDonough presented the Board with year-to-date revenue and inspection statistics. He noted that civil penalty revenue is lower than in previous years. Compliance check activity remains consistent with prior years; however, the number of failures has decreased. The Board discussed that increased compliance among permit holders has resulted in fewer violations and lower civil penalty revenue, which reflects the Board's goal of improving compliance.
