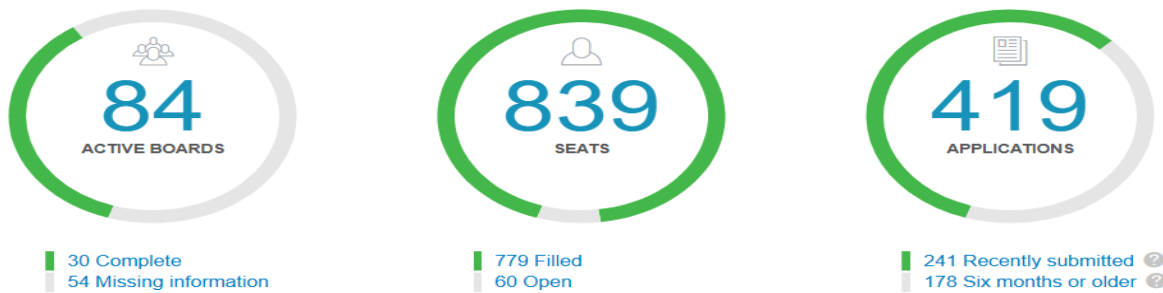


Boards and Commissions Graphs

Graph 1

Presents information about board membership. There are currently 84 active board members, with complete information available for 30 boards and incomplete information for 54 boards. Among the 839 total board seats, 779 are occupied while 60 are unoccupied. Furthermore, there are 419 pending membership applications, with 241 recently submitted and 178 submitted more than six months ago.



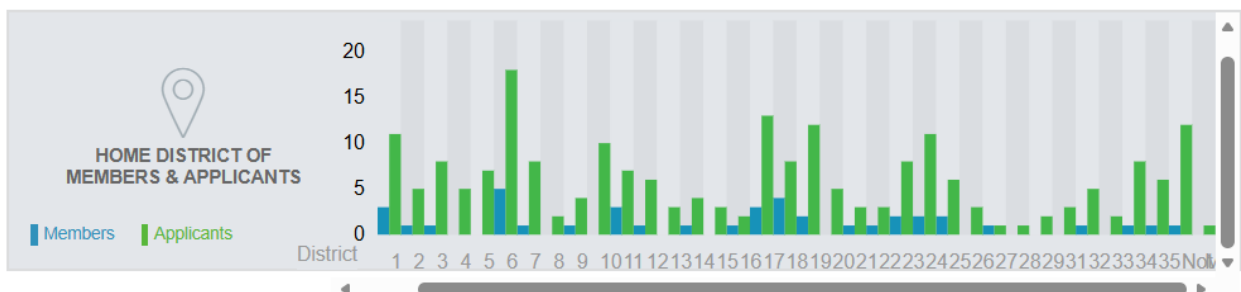
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in July 2025 and the lowest number in December 2025.



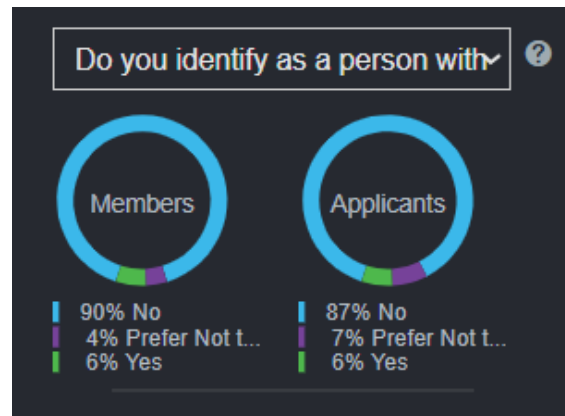
Graph 3

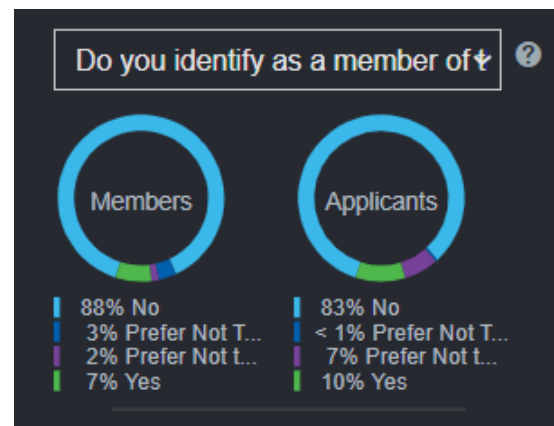
Graph 4

Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 90% answered no, 4% prefer not to say, and 6% answered yes. For applicants 87% answered no, 7% prefer not to say, and 6% answered yes



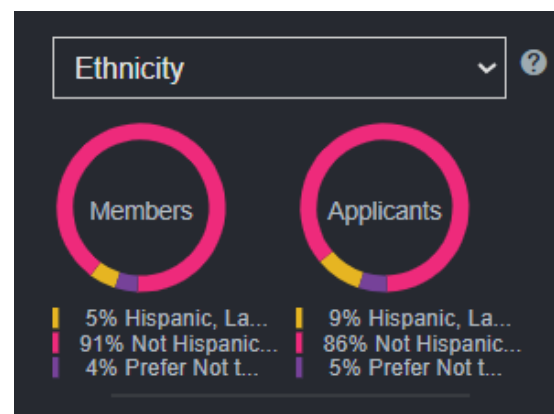
Graph 5

Presents data on LGBTQ+. For Members 88% do not wish to identify as LGBTQ+, 5% prefer not to say, and 7% openly identify as LGBTQ+. For Applicants 83% do not wish to identify as LGBTQ+, 7% prefer not to say, and 10% openly identify as LGBTQ+.



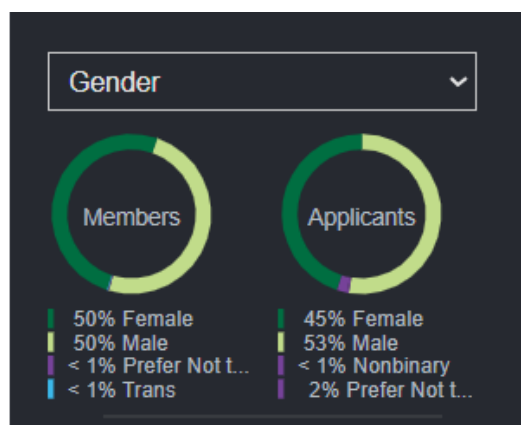
Graph 6

Data on Ethnicity show among members, 5% identify as Hispanic, Latino, or of Spanish origin, 91% do not identify as Hispanic, Latino, or of Spanish origin, and 4% prefer not to say. For applicants, 9% identify as Hispanic, Latino, or of Spanish origin, 86% do not identify as Hispanic, Latino, or of Spanish origin, and 5% prefer not to say.

Data on Gender status show among members 50% identify as female, 50% identify as male, less than 1% prefer not to say, and less than 1% identify as Transgender. For applicants, 45% identify as female, 53% identify as male, less than 1% identify as Nonbinary, and 2% Prefer Not to Say.



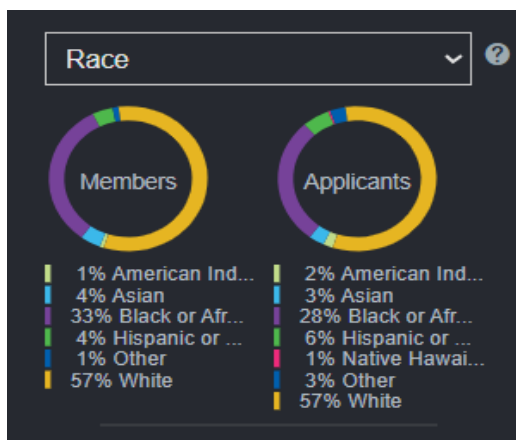
Graph 8

Presents data on years of service on the Metro Boards and Commission. For members 25% served 1-2 years, 14% 2-3 years, 15% 3-4 years, 12% 4-5 years, 34% 5+ years. For applicants 32% served 1-2 years, 16% 2-3 years, 16% 3-4 years, 9% 4-5 years, 27% 5+ years.

Data on Race Group. For members 1% American Indian, 4% Asian, 33% Black or African American, 4% Hispanic or Latino, 1% Other, 57% White. For applicants, 2% American Indian, 3% Asian, 28% Black or African American, 6% Hispanic or Latino, 1% Native Hawaiian or Pacific Islander, 3% Other, 57% White.

Data provides information regarding individuals who are lobbyists. For members 98% answered no and 2% answered yes. For applicants 98% answered no and 2% answered yes.

Illustrates the distribution of members and applicants across various districts of residence.
