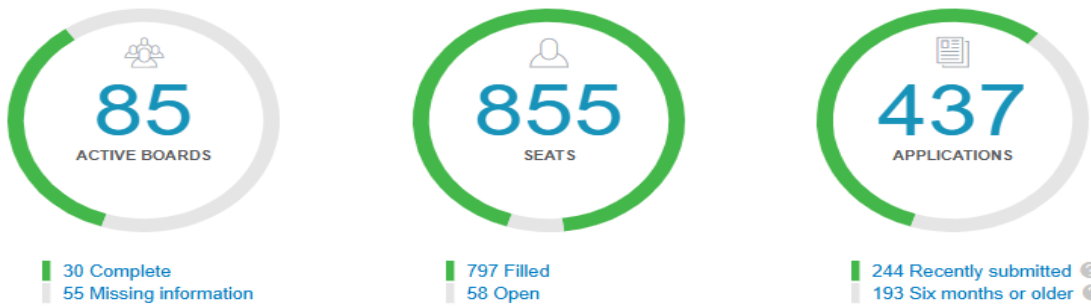


Boards and Commissions Graphs

Graph 1

Presents information about board membership. There are currently 85 active board members, with complete information available for 30 boards and incomplete information for 55 boards. Among the 855 total board seats, 797 are occupied while 58 are unoccupied. Furthermore, there are 437 pending membership applications, with 244 recently submitted and 193 submitted more than six months ago.



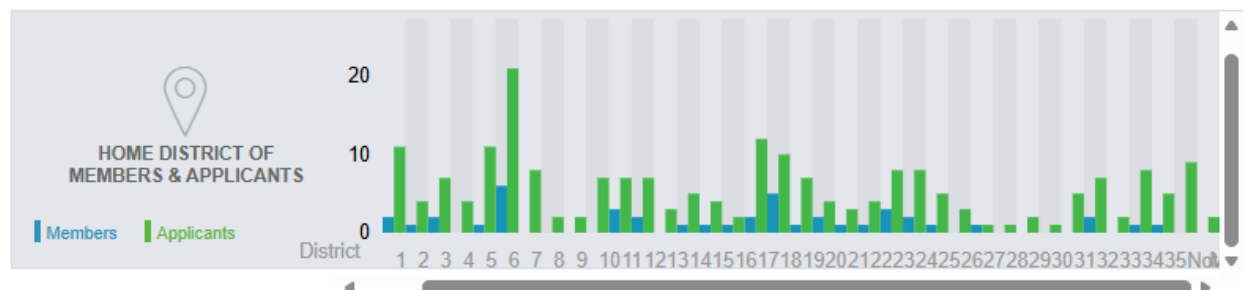
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in May 2027 and the lowest number in July 2026.



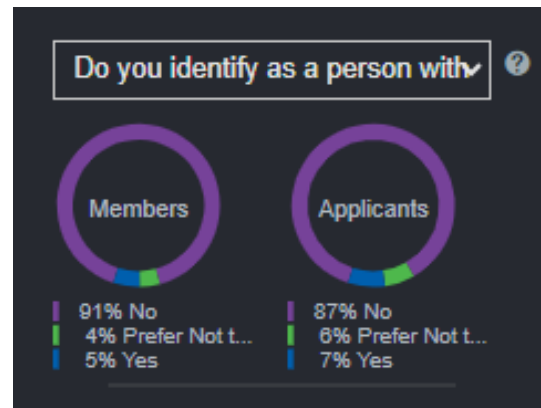
Graph 3

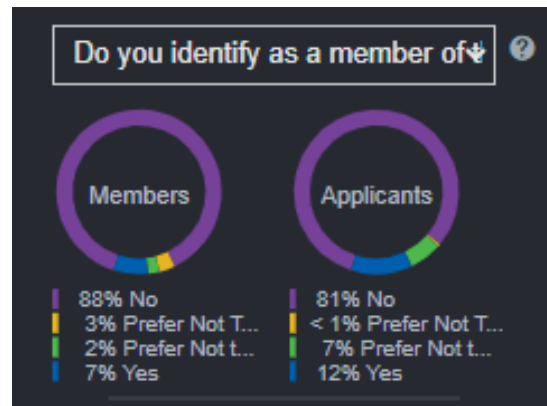
Graph 4

Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 91% answered no, 4% prefer not to say, and 5% answered yes. For applicants 87% answered no, 6% prefer not to say, and 7% answered yes.



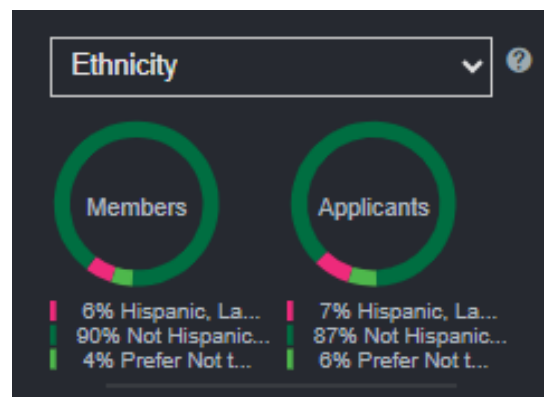
Graph 5

Presents data on LGBTQ+. For Members 88% do not wish to identify as LGBTQ+, 5% prefer not to say, and 7% openly identify as LGBTQ+. For Applicants 81% do not wish to identify as LGBTQ+, 6% prefer not to say, and 12% openly identify as LGBTQ+.



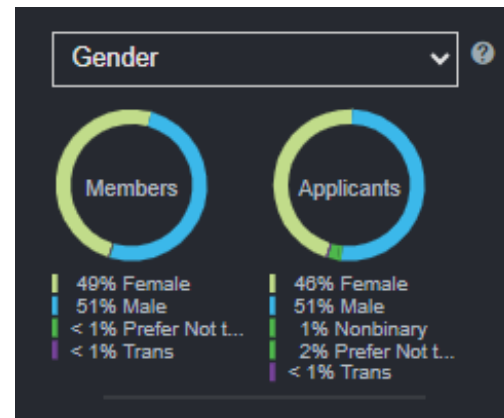
Graph 6

Data on Ethnicity show among members, 6% identify as Hispanic, Latino, or of Spanish origin, 90% do not identify as Hispanic, Latino, or of Spanish origin, and 4% prefer not to say. For applicants, 7% identify as Hispanic, Latino, or of Spanish origin, 87% do not identify as Hispanic, Latino, or of Spanish origin, and 6% prefer not to say.

Data on Gender status show among members 49% identify as female, 51% identify as male, less than 1% prefer not to say, and less than 1% identify as Transgender. For applicants, 46% identify as female, 51% identify as male, 1% identify as Nonbinary, and 2% Prefer Not to Say, and less than 1% Trans.



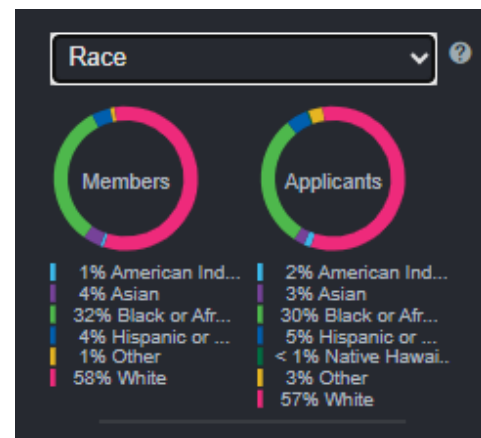
Graph 8

Presents data on years of service on the Metro Boards and Commission. For members 26% served 1-2 years, 14% 2-3 years, 16% 3-4 years, 11% 4-5 years, 33% 5+ years. For applicants 29% served 1-2 years, 19% 2-3 years, 13% 3-4 years, 11% 4-5 years, 28% 5+ years.

Data on Race Group. For members 1% American Indian, 4% Asian, 32% Black or African American, 4% Hispanic or Latino, 1% Other, 58% White. For applicants, 2% American Indian, 3% Asian, 30% Black or African American, 5% Hispanic or Latino, less than 1% Native Hawaiian or Pacific Islander, 3% Other, 57% White.

Data provides information regarding individuals who are lobbyists. For members 98% answered no and 2% answered yes. For applicants 99% answered no and 1% answered yes.

Illustrates the distribution of members and applicants across various districts of residence.
