

MTLC Proposed Rule Changes for August 18th Meeting

Section 223 FEES

Pursuant to various sections in 6.72 of the Metropolitan Code of Laws, the following fees are adopted for the licensing and permitting of taxicab vehicle companies, drivers and vehicles:

a. Company application fee:	\$900
b. Annual vehicle permit fee:	\$75
c. Additional vehicle permits application fee:	\$700
d. New driver permit fee:	\$60
e. Driver permit renewal fee:	\$30
f. Company affiliation change fee:	\$10
g. Background check fee:	\$75

Section 233 COMPANY REPORTING AND PAYMENT OF FEES

All taxicab companies will submit current vehicle and driver lists to the commission staff, in a format prescribed by the director, no later than the first of each month. A \$45 quarterly fee per vehicle decal must be paid no later than January 1, April 1, July 1, and October 1 of each year.

Section 327 FEES

Pursuant to various sections in 6.80 of the Metropolitan Code of Laws, the following fees are adopted for the licensing and permitting of wrecker and towing service companies, drivers and vehicles:

a. General wrecker company application fee:	\$250
b. Non-consent company application fee:	\$100
c. Emergency zone wrecker company application fee:	\$500
d. Emergency wrecker service zone transfer fee:	\$250
e. Emergency wrecker annual vehicle permit fee:	\$100

- f. General and non-consent annual vehicle permit fee: \$35
- g. Driver permit fee: \$90
- h. Driver permit replacement fee: \$10
- i. Non-TBI background check fee: \$40

Section 503 FEES

Pursuant to various sections in 6.74 of the Metropolitan Code of Laws, the following fees are adopted for the licensing and permitting of other passenger vehicles for hire companies, drivers and vehicles:

- a. Company application fee: \$200 (1-5 Vehicles), \$500 (6-10 Vehicles), \$750 (11+ Vehicles)
- b. Annual vehicle permit fee: \$50
- c. Driver permit fee: \$50
- d. Driver permit replacement fee: \$10
- e. Background check fee: \$75

Section 600 LICENSING AND PERMITTING FEES

Pursuant to various sections in 6.73 of the Metropolitan Code of Laws, the following fees are adopted for the licensing and permitting of low-speed vehicle companies, drivers and vehicles:

- a. Company application fee: \$750
- b. Annual company renewal fee: \$250
- c. Annual vehicle permit fee: \$50
- d. Additional vehicle permits application fee: \$100
- e. Driver permit fee: \$40
- f. Driver permit replacement fee: \$20
- g. Criminal background fee: \$75

Section 700 LICENSING AND PERMITTING FEES

Pursuant to various sections in 6.75 of the Metropolitan Code of Laws, the following fees are adopted for the licensing and permitting of pedicab and pedal carriage companies, drivers, and vehicles:

a. Company application fee:	\$645
b. Annual company renewal fee:	\$250
c. Annual vehicle permit fee:	\$50
d. Additional vehicle permits application fee:	\$100
e. Driver permit fee:	\$40
f. Driver permit replacement fee:	\$20
g. Criminal background fee:	\$75
