Commissioner Poole was absent, and Commissioner Link arrived during public comment period.

Chairman Farmer called the meeting to order. He asked if there were any corrections or additions to the minutes of the last Regular meeting on **July 14, 2026**. Commissioner Sanders moved to accept the minutes for the **July 14, 2026**, meeting. The motion was seconded by Commissioner Jones, and commissioners Jones and Sanders approved without objection. Chairman Farmer asked if there were any union representatives in attendance. SEIU representatives were present. Abby Greer read the Announcement of Appeals Process. Chairman Farmer asked the Commissioners if they had received any Communiqués from the public.
