



Water Quality SCM Maintenance Companies Serving Nashville

The following is a list of companies that inspect and facilitate maintenance for post-construction water quality Stormwater Control Measures (SCMs), such as underground detention units, bioretention basins, pervious concrete, and stormwater ponds. Each company on this list has submitted a signed statement to Metro that states their company will abide by the following guidelines:

- The Company will not provide inaccurate representation/advertisement of the Metro SCM Maintenance Company List or hold itself out as an agent or representative of Metro;
- The Company will accurately communicate Metro SCM inspection and maintenance requirements to the public and clearly identify optional measures recommended by the Company but not required by Metro;
- The Company will abide by all applicable Federal, State, and Local maintenance-related material disposal guidelines;
- The Company will abide by all Occupational Safety and Health Administration (OSHA) and TOSHA guidelines in performing SCM inspections and maintenance; and
- The Company will follow all SCM inspection/maintenance reporting requirements, as established by stormwater regulations and LTMA's for properties' SCMs constructed after 2007.
